**DECLARATION OF SARA RAWSON**

I, Sara Rawson, hereby declare as follows:

1. I am over the age of 18 years. I am a Litigation Paralegal at Amazon.com, Inc. (“Amazon”). Based on my position at Amazon, I am familiar with Amazon’s email system and have experience with sending mass email messages to Amazon customers. I have personal knowledge of the facts contained herein, and, if called as a witness, I could and would competently testify to those facts.

2. On January 7, 2020, I caused an email to be sent out on behalf of, and in the name of Amazon to email addresses associated with Amazon customers who Amazon’s records indicate purchased Evanger’s Hunk of Beef, Evanger’s Braised Beef, or Against the Grain Pulled Beef with Gravy, from Amazon’s website between December 1, 2015 and June 30, 2017.

3. The subject of the email message was “Notice Regarding Class Action Settlement.” The body of the email message was in the following form:

Amazon is emailing you because our records indicate that you may have purchased Evanger’s Hunk of Beef, Evanger’s Braised Beef, or Against the Grain Pulled Beef with Gravy between December 1, 2015 and June 30, 2017. If so, you may be entitled to receive money or product certificates from a class action settlement. In *Mael v. Evanger’s Co.*, a federal court in Washington preliminarily approved the settlement of a class action lawsuit involving these products. The Court did not decide in favor of plaintiffs or defendants, but both sides have agreed to a settlement.


Amazon is sending this email on behalf of the parties to the lawsuit, and as required by the Court. Because we are not involved in the lawsuit, we cannot assist you directly. To determine whether you are a member of the class,

1 obtain a copy of the Settlement Agreement, view the full notice approved by  
2 the Court, and file a claim, please go to [www.evangerssettlement.com](http://www.evangerssettlement.com) or call  
3 the Settlement Administrator at 1(888) 404-0223. You must submit a valid  
4 claim to receive a cash payment or product certificate. The full notice also  
5 provides details on how to opt out or object to the settlement. Claims and opt  
6 outs must be submitted by March 9, 2020. Objections must be received by the  
7 Court by March 9, 2020.
